ACCOUNTABILITY OF FUNDS

This recurring budget request supports the department's Strategic Objective 5 (Sustain and expand the military presence in South Carolina) and underwrites the corresponding Focus Area - Intent of the Military Installation Focus -- which advocates South Carolina as an indispensable component of national defense.

Pursuant to Proviso, funds distribution is permissible to counties and municipalities with federal military installations that identify programs and services for: conducting land acquisition, supporting recreational, educational and facility-related requirements for military personnel and their families. The award of funds are for projects that enhance military value, military installation resilience and / or military family quality of life. A report of project expenditure occurs quarterly.

There are two key screening criteria for discerning base closure and allocation of federal funds: (1) the ability of a base to meet operational requirements associated with its assigned missions, and (2) the ability of the surrounding community to meet critical quality of life requirements of military families. The Military Enhancement Fund provides a viable approach to solving complex and sensitive challenges while [subsequently] yielding high-value impact to the state's economy and reducing the likelihood of base closures; amplifying the state's position as essential component of national defense.

What specific strategy, as outlined in the most recent Strategic Planning and Performance Measurement template of agency's accountability report, does this funding request support? How would this request advance that strategy? How would the use of these funds be evaluated?

Distribution of funds occurs through a grant-like program. County and municipal applications with a federal military installation submits a viable proposal to either improve the operational capability of a South Carolina military installation or improve the quality of life of military families in South Carolina. The Department of Veterans' Affairs (1) periodically reviews and evaluates grant proposals through a formal board process, (2) awards funding to the most promising proposals, (3) monitors the conduct of awardee program management and expenditures and (4) reports programs successes and expense reports to the General Assembly and Office of the Governor. Specific Military Enhancement Fund criteria follows:

Eligibility Criteria

Proposal must meet all of the below minimum requirements. Applications lacking requisite information are not considered.

A. Identify as one of the following counties or municipal government agents / agencies

with a federal military installation, as defined above, within or adjacent to jurisdictional boundaries of the county or municipality: Richland, Sumter, Charleston, Berkeley, Dorchester, Beaufort, Orangeburg, Georgetown, Edgefield or Aiken

B. Clearly demonstrate how funding increase military value, and /or military installation resilience and / or enhances military family quality of life at the supported military installation(s). The proposal may include and not limited to land acquisition, recreational and education purposes and facility sustainment, restoration and modernization for military personnel.

C. Include a signed letter of support by (the) local installation commander(s) representing the installation(s) or military community(ies) that benefit from the proposal.

- D. Additionally, include the following items:
- 1. A cover letter on county or municipal government agency letterhead briefly describing the scope of the proposal and identifying the military installation(s) that benefit.
- 2. Provide a detailed written explanation of the proposal: to include the following:

Evaluation Criteria

The South Carolina Department of Veterans' Affairs evaluates each proposal based on (1) the impact to mission readiness, (2) effect on military quality of life, (3) effect on the surrounding community, (4) project timeliness and (5) the degree to which project costs are shared among other funding sources. The department makes every effort to fund selected proposals at the amount requested. However, the Secretary may adjust award amounts based on the availability of funds and other considerations. Final decision authority for awarding grants under this program rests with the Secretary of the Department of Veterans' Affairs. If a grant is not awarded in full the department may request an updated budget from the applicant.

What individuals or entities would receive these funds (contractors, vendors, grantees, individual beneficiaries, etc.)? How would these funds be allocated – using an existing formula, through a competitive process, based upon predetermined eligibility criteria?

With more than 11% of South Carolina's economy attributed to the military presence in our state, South Carolina has a vested interest in maintaining and, if possible, expanding the state's military presence. In June 2022, the University of South Carolina estimates that the impact of military bases and communities yield more than \$34B (or 11+%) of the state's economy. Report details are located at: https://scdva.sc.gov/sites/scd...).

In recognizing the growth and value of the projects funded by the Military Enhancement Fund, the General Assembly approved \$2M in recurring funds for FY24-25. Additionally, the General Assembly's passage of legislation to add Fort Eisenhower to the list of federal military installations for South Carolina underscores the importance of the corresponding \$1.8B economic impact to South Carolina (see Economic Impact link above). As a result, South Carolina counties of Edgefield and Aiken are eligible to participate in the Military Enhancement Fund program. With the inclusion of additional communities, additional funding for this growing and valuable program is necessary. In FY24-25, proposals were approved for a marine firefighting school and wastewater treatment. Additional proposals were submitted for energy resilience and drone protection.

JUSTIFICATION OF REQUEST

From FY21-22 to FY24-25, the General Assembly appropriated a total of \$35.5M for the expressed purpose of supporting actions and programs that make South Carolina a more appealing location for military bases and military families. Awards supporting non-operational military requirements and quality of life improvement total \$32.6M.

In FY24-25, proposals were approved in the amount of \$7.6M for a marine firefighting school in Charleston and an updated wastewater treatment equipment in Beaufort and Port Royal. The department is evaluating additional proposals totaling more than \$6.4M for energy resilience, protection from drones, equipment for a cyber school and dam repair.

Sustaining and expanding military presence in South Carolina requires continuous deliberate engagement in the years ahead; especially when considering shrinking national defense budgets—which greatly increases the desire to consolidate military bases by eliminating those bases with lowest operational value. This budget request reflects our state's commitment to underwrite the necessary conditions to posture South Carolina as the most attractive location for military bases and military families.

The estimated fiscal impact of this proviso is approximately \$10 million.

FISCAL IMPACT

The average amount of funded proposals based on the last three fiscal years is approximately \$9.4 million per year. The proposed proviso change would make the grants available to a larger group. An estimated increase of 25% in funded grants brings that amount to \$\$11.75 million. We currently receive \$2 million in recurring funds for the Military Enhancement Fund, which leaves a need for approximately \$9.75 million in additional recurring funding.

South Carolina is home to eight military installations. These installations, plus Fort Gordon in GA, contribute \$34.3 billion to South Carolina's economy, based on the 2022 Economic Impact Study. These installations play a critical role in national security.

The Military Enhancement Fund assists these installations with mission readiness and quality of life issues. The proviso revision allows Military Enhancement funds to support a larger portion of the military in South Carolina.

The impact of a funding reduction to the Military Enhancement Program presents moderate risk and understandably adversely impacts the Department's ability to underwrite initiatives that improve the (1) operational capability of South Carolina military installations and (2) the quality of life of military families in South Carolina in counties and / or municipalities with a federal military installation.

Remaining impact to resourcing quality of life durable equipment (e.g., washer, dryer, range over) is manageable with a 50% reduction in each Veteran Home Operating Expense Budget and a combined 36% reduction in Veteran Affairs Operating Expense Budget.

What programs or activities are supported by the General Funds identified?

The main component of the Department's budget request is distributed across a single focus area within the construct of the department's strategic plan: Focus Area 5 - Expand the Military Enterprise with the intent to make South Carolina and indispensable component of nations defense.

My budget request for Fiscal Year 2026-2027 is nominal at 6% (or \$10M) -- when considering the South Carolina General Assembly's generous prior-year appropriation approvals across the range of programs and services the department delivers to a special segment of South Carolinians.

As the Department looks forward beyond the recent transition of five and establishment of the last of six State Veteran Homes, my request of \$10M sustains and expands that nation's military presence in South Carolina. Sustainment and expansion set conditions for continuous deliberate engagement in the years ahead; especially when considering shrinking national defense budgets.

A reduction in federal (military) spending greatly increases the desire to consolidate military bases by eliminating those bases with lowest operational value. This budget request reflects our state's commitment to underwrite the necessary conditions to posture South Carolina as the most attractive location for military bases and military families.
