R080	Workers' Compensation Commission	38440000	PENALTIES FINES	\$367,517	\$4,746,031	7.74%	§42-5-40 authorizes the Commission to assess a fine against employers that are required to carry workers' compensation coverage, but fail to do so. §42-519-30 authorizes the Commission to assess fines against insurance carriers for failure to submit required reports, §42-3-105 authorizes the Commission to double the amount of fines and penalties assessed unless the employer is uninsured. If the employer is uninsured, the statute provides a minimum and a maximum penalty. §42-3-175 authorizes the Commission to impose monetary sanctions for willful disobedience of an order.
