REQUEST FOR LEASE PROPOSAL FOR <u>SPARANBURG COMMUNITY COLLEGE</u> OFFICE/LAB SPACE IN SPARTANBURG COUNTY

No lease agreement with the State is final without the approval of designated authorities as governed by South Carolina law. Real Property Services reserves the right to negotiate lease terms with submitting parties until such final approval is granted. State law prohibits any party participating in this solicitation process from making direct contact with the agency seeking space until a final lease has been approved. All correspondence should be directed to Real Property Services. Prior to lease negotiation, Landlord may be required to provide a list of all partners or members where Landlord is an LLC or partnership (to include all tiers so that individuals are named).

Properties selected for site visits will be chosen based on a cost analysis of the submitted proposals, the responsiveness of the proposals to the stated requirements, and the space efficiency of proposed floor plans submitted; therefore, best proposals should be submitted initially.

LEASE CRITERIA – SPARTANBURG COMMUNITY COLLEGE

- Location: Spartanburg County, Spartanburg, South Carolina
- Expected occupancy date: As soon as possible
- Total space needed is approximately <u>12,500</u> rentable square feet +/- depending on circulation and common area factor. Please include both rentable and usable square feet in proposal and include the common area factor (%).
- Ideal set up should include, but is not limited to:
 - o 3 private office(s) for professional staff of approximately 120 square feet each
 - Open space for 1 workstation of approximately 48 square feet
 - Open space for 1 small workstation of approximately 25 square feet
 - o 1 medium-sized lobby, to accommodate 4-6 people of approximately 100 square feet
 - o 1 beverage alcove of approximately 24 square feet
 - o 1 large breakroom to accommodate 8-10 people of approximately 200 square feet
 - o 3 classrooms to accommodate 20 students of approximately 700 square feet each
 - o Lab space of approximately 4,500 square feet
 - 1 dispensary, including a sink, countertops, and cabinets, of approximately 500 square feet
 - o 1 IT closet with wall mounted racks of approximately 40 square feet
 - o 1 print alcove with 8 linear feet of upper and lower cabinets of approximately 40 square feet
 - 1 medium conference room to accommodate 6-8 people of approximately 250 square feet
 - 1 large storage room of approximately 250 square feet
- Landlord is responsible for ensuring that any space proposed meets all American Disabilities
 Act (ADA) requirements and shall be responsible for all costs associated with ADA
 compliance.

- Cabling must be certified to CAT-6 standards, with all terminations by the Landlord. All
 internet connections, phone/data connections, electrical and other outlets to be provided by
 the Landlord throughout the space as specified by Agency.
- 54 parking spaces are required, 4 of which should be reserved for employees.
- Parking lot must be paved and lighted.
- Term: Please provide proposed rates for 3, 5, 7 or 10-year terms.
- Proposals should be for a MODIFIED GROSS lease to include operating expenses, such as
 utilities, grounds maintenance, repairs, taxes, insurance, general building maintenance,
 building equipment maintenance, electrical systems maintenance, HVAC maintenance,
 plumbing maintenance and any other service necessary to maintain and operate all building
 and site improvements. Spartanburg Community College will provide janitorial and security
 services.
- The following proposals are not preferred and may be eliminated from consideration. Proposals that require:
 - reimbursement of tenant improvement costs upon early termination
 - use of a lease form that differs from the Standard State Lease form (standard state lease form <u>found here</u> or available upon request).

MINIMUM STATE REQUIREMENTS

- Property must be barrier free, hazard free and smoke free.
- Property must meet zoning requirements for proposed use.
- Economical and efficient space utilization.

PROPOSAL DUE DATE AND REMITTANCE INSTRUCTIONS:

- Please submit proposals to the Department of Administration, Real Property Services on or before **June 6**, **2024 4:00 PM**.
- All proposals must be in writing and may be submitted by mail or e-mail. (It is agent's responsibility to ensure receipt). Please submit proposals on the FMPS-202E form.
- Proposals should specify floor usable and rentable square feet (if applicable) and should be calculated according to the ANSI/BOMA-Z65.1-1996 standard.
- Please attach a proposed floor plan.
