Funds will invest in evidence-based, community-based, juvenile delinquency prevention interventions targeting at-risk youth. The interventions will include: Multisystemic Therapy and Functional Family Therapy; funds to the SC Afterschool Alliance for expanded summer programs, especially in rural areas of our state; teen afterschool programs; and full-time mentoring programs in public schools in 2021-22 school year.</p>	\$10,510,633

Note: Unobligated federal ARP EANS funds revert to the Governor for uses under the GEER Program. These funds are available for obligation through September 30, 2024.

South Carolina received \$40.3 million in ARP EANS funds of which \$15 million was spent, leaving \$25.3 million redirected to the GEER Program. The expenditure of ARP EANS funds were the same as those in section 312(d) of the CRRSA Act with two exceptions:

- A State educational agency (SEA), the SC Department of Education, could only provide services or assistance under ARP EANS to non-public schools that enroll a significant percentage of students from low-income families and are most impacted by COVID-19; and
- An SEA, the SC Department of Education, could not use ARP EANS funds to provide reimbursements to any non-public school as authorized under section 312(d)(4)(M) of the CRRSA Act.
